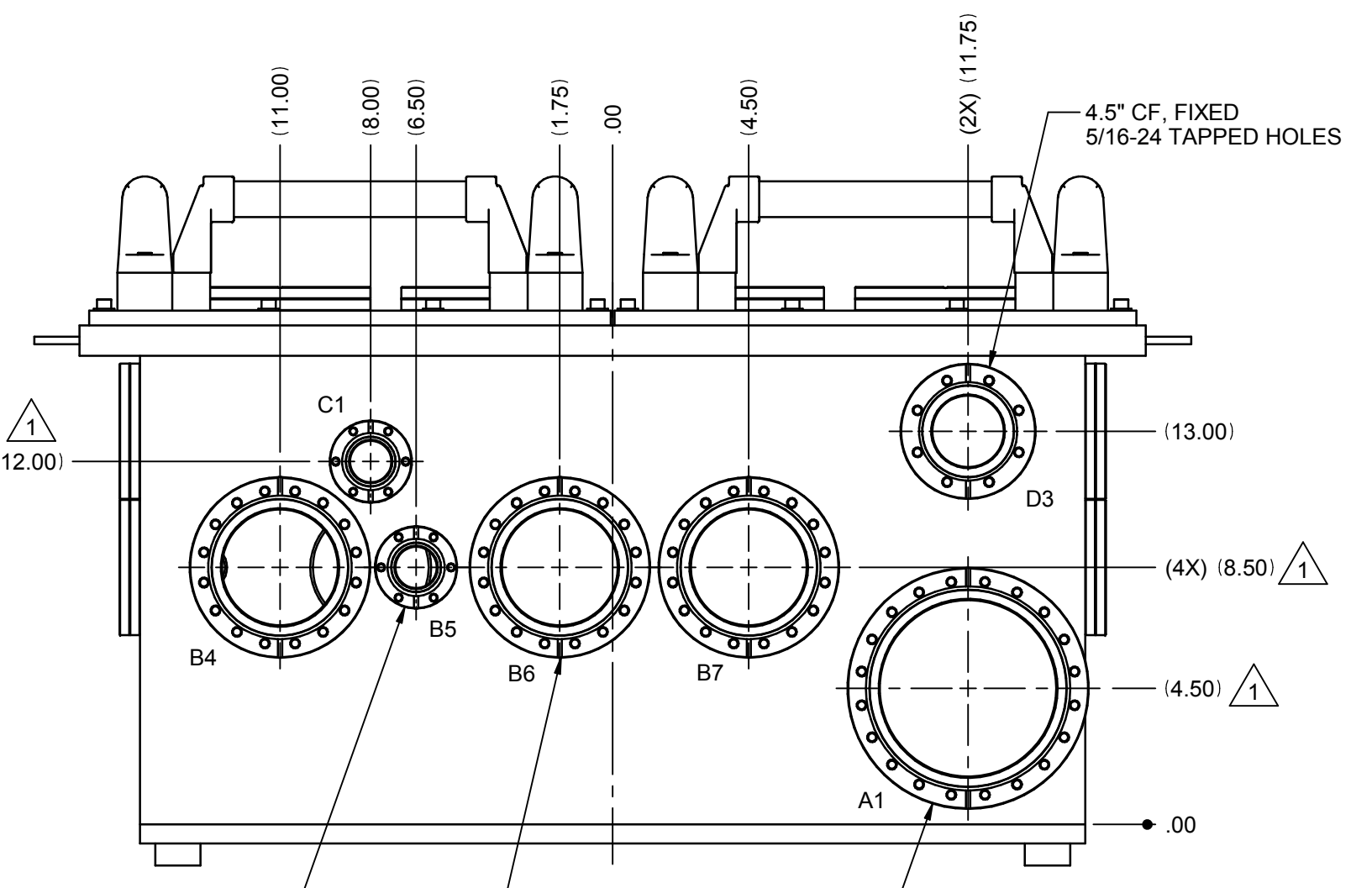
LEFT SIDE VIEW



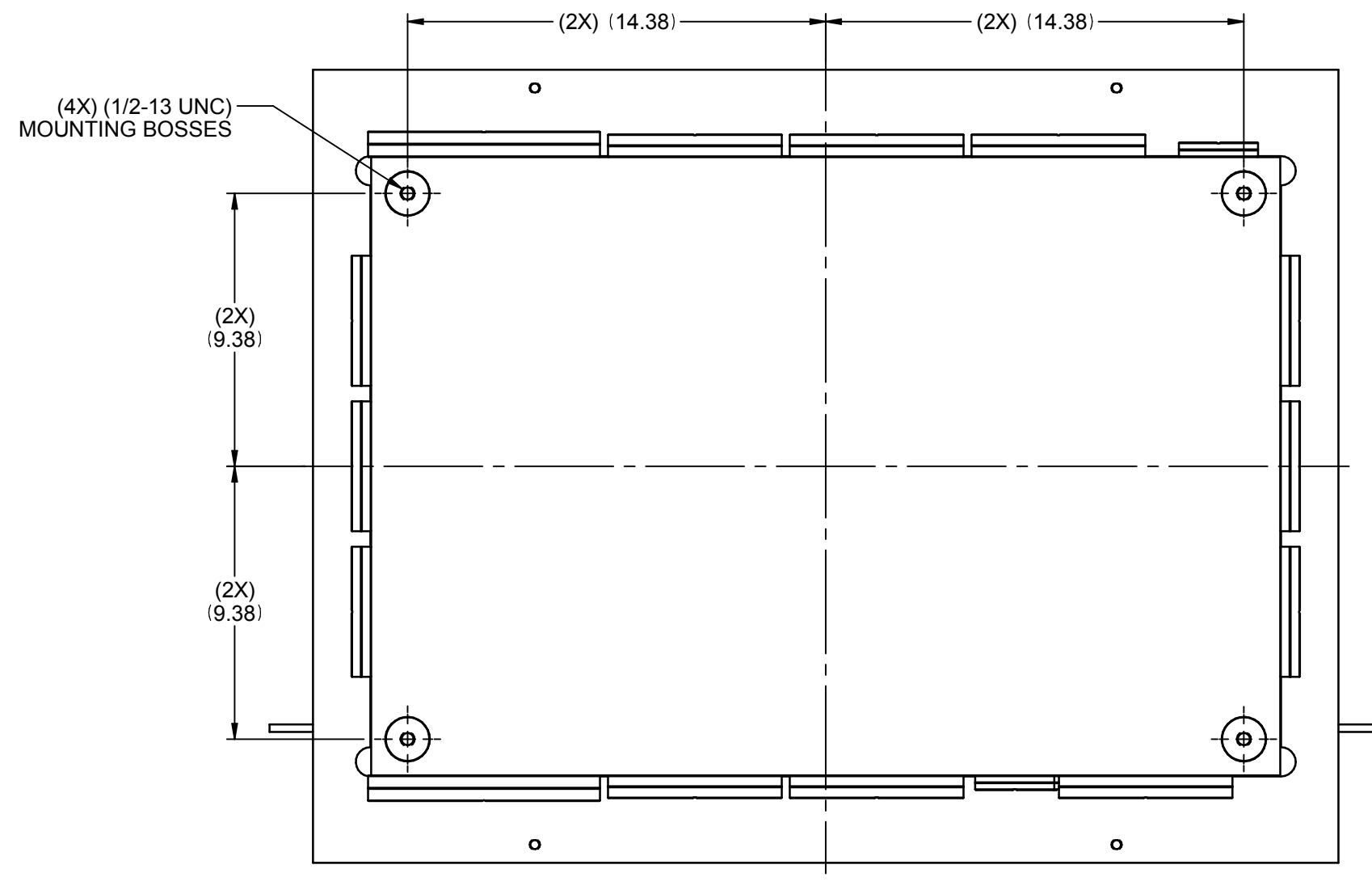
FRONT VIEW
